Pursuant to **Regulation 15** of the **SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**, the compliance with the Corporate Governance provisions specified under the following regulations: -

- Regulation 17 to Regulation 27;
- Clauses (b) to (i) of sub-regulation (2) of Regulation 46; and
- Para C, D and E of Schedule V,

shall not apply to in respect of the following classes of listed entities:

- a) Listed entities having **paid-up equity share capital not exceeding Rs. 10 crore** and **net worth not exceeding Rs. 25 crores**, as on the last day of the previous financial year; or

share capital exceeds ₹10 crore or whose net worth exceeds ₹25 crore as on the last day of the immediately preceding financial year.

## **NON-APPLICABILITY CERTIFICATE OF CORPORATE GOVERNANCE**

This is to certify that the Company, i.e., “CITYON SYSTEMS (INDIA) LIMITED” vide **Scrip Code: 780013**, has listed its specified securities on SME Exchange (ITP) of BSE Limited and hence the provisions of Regulation 27 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015, read with Regulation 15 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015, are not applicable to the Company. Thus, it is not required to submit the Quarterly Compliance Report on Corporate Governance for the Quarter ended on 30<sup>th</sup> September, 2025.

However, in terms of the amendment notified with effect from April 01, 2025, it is hereby noted that:

*“Provided that with effect from April 01, 2025, the provisions of Regulation 23 shall be applicable in respect of a listed entity which has listed its specified securities on the SME Exchange and which has either paid up equity share capital exceeding Rupees ten crore or net worth exceeding Rupees twenty-five crore, as on the last day of the previous financial year.”*

In view of the above, **Cityon Systems (India) Limited** confirms that the provisions of Corporate Governance are not applicable to the Company, except Regulation 23 (Related Party Transactions), which is applicable since the Company’s paid-up equity share capital and net worth exceed ₹10 crore and ₹25 crore, respectively. The Company affirms that it is in compliance with the requirements of Regulation 23 of the SEBI (LODR) Regulations, 2015.

Accordingly, the Company is not obligated to file the Quarterly Corporate Governance Report under Regulation 27 of the SEBI (LODR) Regulations, 2015 for the quarter ended 30<sup>th</sup> September, 2025, other than maintaining compliance with Regulation 23.
